




Spatial Distribution

LED is recommended for reflow soldering and soldering profile is shown below.




Reflow Soldering Profile for SMD Products (Pb-Free Components)


1. All temperatures refer to the center of the package, measured on the package body surface facing up during reflow. Do not apply any stress to the LED during high temperature conditions.
Maximum number of soldering passes: 2





Recommended Soldering Pattern (Units : mm; Tolerance: ± 0.1)






Reel Dimension (Units : mm)

1. Wavelength: +/-1nm


2. Luminous intensity / luminous flux: +/-15%
