






LED is recommended for reflow soldering and soldering profile is shown below.

Reflow Soldering Profile for SMD Products (Pb-Free Components)




- 1. Maximum soldering temperature should not exceed 260°C


♦ Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)


If special sorting is required (e.g. binning based on forward voltage, luminous intensity / luminous flux or chromaticity), the typical accuracy of the sorting process is as follows:
