measured on the package body surface facing up during reflow. 2. Do not apply any stress to the LED during high temperature conditions. 3. Maximum number of soldering passes: 2





## Recommended Soldering Pattern (Units : mm; Tolerance: ± 0.1)




Mask open area ratio:80% Mask thickness:80~100um

1. Wavelength: +/-1nm


2. Luminous intensity / luminous flux: +/-15%
