









Relative Intensity Vs. CIE Wavelength








## LED is recommended for reflow soldering and soldering profile is shown below.

Reflow Soldering Profile for SMD Products (Pb-Free Components)




- 1. All temperatures refer to the center of the package,
- measured on the package body surface facing up during reflow.


  2. Do not apply any stress to the LED during high temperature conditions.


  3. Maximum number of soldering passes: 2

### **❖** Recommended Soldering Pattern (Units: mm; Tolerance: ±0.15)




### **❖** Tape Specification (Units:mm)

#### Remarks:


If special sorting is required (e.g. binning based on forward voltage, Luminous intensity / luminous flux, or wavelength), the typical accuracy of the sorting process is as follows:


- 1. Wavelength: +/-1nm
- 2. Luminous intensity / luminous flux: +/-15%
- 3. Forward Voltage: +/-0.1V

Note: Accuracy may depend on the sorting parameters.
