









Spatial Distribution








LED is recommended for reflow soldering and soldering profile is shown below.


Reflow Soldering Profile for SMD Products (Pb-Free Components)




- 1. All temperatures refer to the center of the package

- 3. Maximum number of soldering passes: 2


❖ The device has a single mounting surface. The device must be mounted according to the specifications.




❖ Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)


- 1. Wavelength: +/-1nm

- 3. Forward Voltage: +/-0.1V


