






### LED is recommended for reflow soldering and soldering profile is shown below.

Reflow Soldering Profile for SMD Products (Pb-Free Components)




- 1. All temperatures refer to the center of the package, measured on the package body surface facing up during reflow.

  3. Maximum number of soldering passes: 2







❖ The device has a single mounting surface. The device must be mounted according to the specifications.




**❖** Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)

#### Remarks:

- 2. Luminous intensity / luminous flux: +/-15%
- 3. Forward Voltage: +/-0.1V




